Community Futures (CF) is a national economic development program supported in western Canada by Prairies Economic Development Canada. Community Futures are nonprofit organizations guided by volunteer boards of directors and staffed with business professionals. Together, CF staff and community volunteers are actively engaged in helping develop and implement community-based economic development and diversification strategies. These strategies create growth within our rural communities one idea at a time.

Access to Capital - CF organizations (CFs) are developmental lenders. Priority is given to viable business ideas that result in wealth generation for the business and economic development for the community or region. CFs may invest in qualified business projects to a maximum of \$150,000.00.

Business Services - CF provides a wide range of coaching, training and technical assistance to businesses, including support with business planning.

Strategic Community Planning & Support - For rural communities to continue to compete in a fast-changing world full of economic uncertainties, they must adopt new economic development strategies. These strategies must be focused and intentional, but also flexible enough to allow the community to capture new opportunities presented by a truly global market place. CF organizations provide community support through strategic planning facilitation.








The Capital Growth Initiative (CGI) loan program was approved by CFNA for offices to continue lending out to women business owners. This program is available for qualifying women owned business within the CFPC region with a competitive rate and a 25% forgivable portion. Staff attended the CFNA Spring Training sessions in Nisku to further enhance their skills. We also had a booth at the Grimshaw & District Chamber of Commerce Business Expo to promote CF services as well as the Entrepreneurship Bursary for students in Grade 12.

May The 16th Annual Women in the North Conferences were held in three communities - Peace River, Fairview & Manning and featured keynote speakers Kristen Cumming who spoke on the generational gap in the workplace and Ariel Haubrich who gave tangible tips on how to manage stress. The day also included the highlight on local business leaders during the Talk Show and as always, door prizes, great food and awesome networking opportunities.

Integra Tire

Trevor Wiebe is a journeyman welder and transport mechanic from Central BC. He started his own business operating a welding truck in 2006. In 2008, Trevor moved to Fort McMurray and gained years of experience working in the tar sands for over seven years. In 2015, he received his Red Seal as a transport mechanic.



Trevor then moved to Peace River to help run a mechanic shop, where he quickly built up his welding and mechanic business and bought his very first service truck. He ran that business from 2017 to 2023, when he purchased Integra Tire. "I started my own business for the growth opportunities it offers. We are a family-oriented business, and I've always wanted a work environment where everyone looks out for each other and gets along. We have more than achieved that goal." Trevor opened the shop with one tire technician and himself. Two weeks later, he added another tire apprentice and a second mechanic. During their first year, they operated with six people and have now grown to 10 employees. Integra Tire is a full-service mechanical business and also have a welder on staff. The facility has six bays, including a drive-through bay that can accommodate a B-train unit . Integra Tire is located in the Sunrise County Business Park in Northern Sunrise County.


Those wishing to serve as a Board Director must be 18 years of age, reside in the region and be committed to support CFPC.
